5. If an election is contested the poll will take place on the THURSDAY 7 MAY 2015.
6. New applications to vote by post and requests to cancel or change an existing postal or proxy vote must reach the Electoral Registration Officer at RUTLAND COUNTY COUNCIL CATMOSE OAKHAM by 5 pm on the 21 April 2015, if they are to be effective for this election.
7. New applications to vote by proxy except on the grounds of a medical emergency must reach the Electoral Registration Officer at RUTLAND COUNTY COUNCIL CATMOSE OAKHAM by 5 pm on the 28 April 2015, if they are to be effective for this election.
8. Applications to vote by proxy on the grounds of an emergency must reach the Electoral Registration Officer at RUTLAND COUNTY COUNCIL CATMOSE OAKHAM by 5 pm on the 7 May 2015 if they are to be effective for this election.
